Pilot Conversion Agreement and Bill of Sale

This agreement converts a 90-day DryLogix pilot into a completed purchase. Until the balance below is paid in full, DryLogix, LLC still owns the hardware. When that payment clears, title to the physical kit on this serial number transfers to the Customer. Software, firmware, dashboard, and DryLogix marks remain property of DryLogix, LLC and are licensed, not sold.

This document is in addition to DLX-LEGAL-001 (Customer Terms and Conditions, End User License, Limited Warranty, and Product Policies). That agreement stays in force. If the two conflict on title transfer for this serial number, this conversion agreement controls.

The pilot fee was a trial/use fee and not a purchase price. It is credited against the purchase price of this serial number. No separate software unlock fee is due. Payment to Morriss Lawn Service LLC or any other MDTI operating company does not constitute payment hereunder. Add-ons are due only if stated on the invoice and not previously paid.

3. When ownership of the hardware transfers

- Before the balance due is received: DryLogix, LLC keeps full title. Customer remains a licensed user and bailee of this serial number only.
- When DryLogix (or MDTI on its behalf) has received the balance due in good funds, and this agreement is signed: title to the physical hardware in the standard kit for this serial number — and any add-on hardware already paid for — passes to Customer.
- Risk of loss on the hardware follows title, except Customer already bears loss, theft, or damage from incorrect installation as stated in DLX-LEGAL-001.
- Customer may not return the unit for the \$200 pilot refund after title has passed. The \$99 restock / shipping / refresh path applies only to an unconverted pilot.

Software, firmware, operator dashboard, documentation, and trademarks do not transfer. On conversion, the 90-day evaluation license becomes the perpetual license in DLX-LEGAL-001 Section 4.2, tied to this serial number only.

4. Product; exclusions

Customer is purchasing the DryLogix Lite monitoring kit identified above. DryLogix does not operate the kiln, replace the kiln controller, or preserve any Nyle, Wood-Mizer, or other kiln-maker warranty. Incorrect attachment is Customer's risk. DryLogix, LLC and MDTI shall have no liability for kiln damage arising from incorrect attachment, and Customer shall not be entitled to a refund if the DryLogix unit is damaged by incorrect attachment.

The limited one (1) year manufacturer warranty in DLX-LEGAL-001 runs from the original delivery date of this serial number and not from the date of this conversion. The warranty does not cover misuse or incorrect attachment.

5. Representations

- The Product is or will be installed in accordance with the DryLogix installation guide.
- Customer has received DLX-LEGAL-001 and agrees to remain bound by it.
- Customer elects to convert this pilot to a purchase and not to return the unit.
- Payment to MDTI as collection agent for DryLogix, LLC is valid consideration for this conversion.

TO THE MAXIMUM EXTENT PERMITTED BY LAW, LIABILITY REMAINS CAPPED AT THE AMOUNT ACTUALLY PAID FOR THIS SERIAL NUMBER, AND WE ARE NOT LIABLE FOR LOST LUMBER, DOWNTIME, KILN DAMAGE, OR VOIDED THIRD-PARTY WARRANTIES, ALL AS STATED IN DLX-LEGAL-001.

6. Execution

This Agreement may be executed in counterparts, including electronic copies. Receipt of the Balance Due in good funds completes the purchase.
